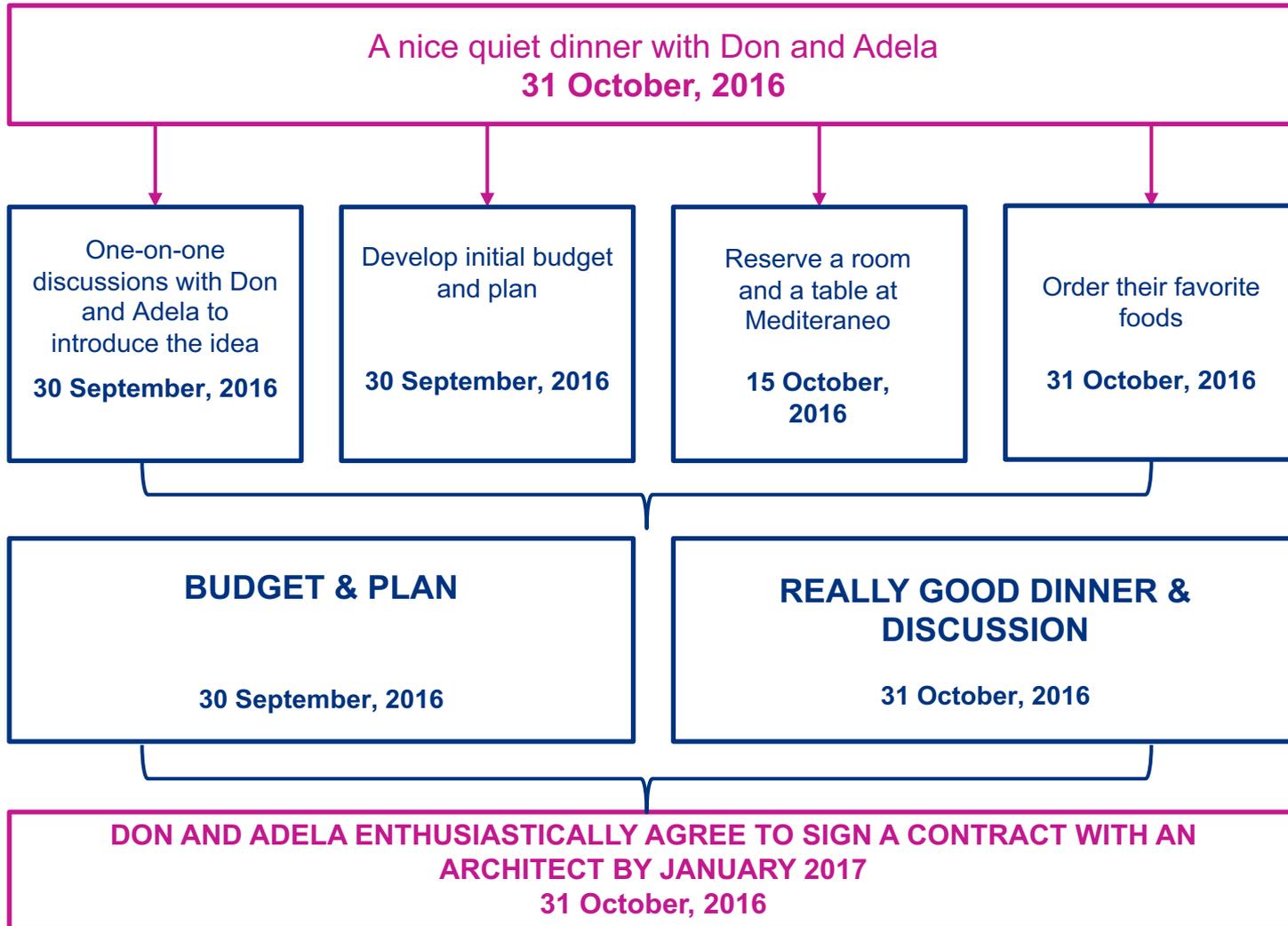
Results Cascade Overview



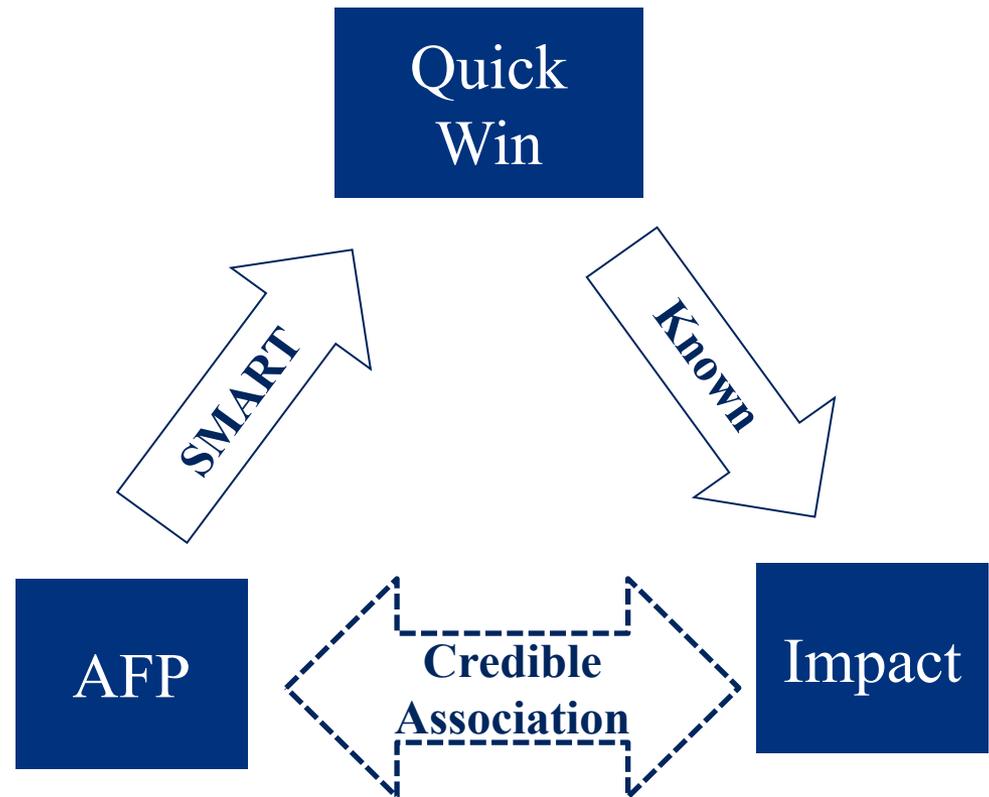

AFP M&E Theory of Change

- Attaining a Quick Win is just the first in a series of steps to achieve impact
- Linking advocacy actions to impact is extremely difficult and costly; however, ...
- Investing in quick wins known to influence impact produces a credible association with the impact



Why is it worth it?

- Organizing a SMART advocacy strategy
- Identifying and overcoming obstacles/setbacks
- Refinement of advocacy activities
- Project management
- Fulfills reporting obligations
- **Connects process, quick wins, and impact**

Why is the Results Cascade useful for advocates?

- To record and share the work and what happened
- To replicate the strategies and tactics used
- To demonstrate strategic expertise to donors and others
- To show that policies fulfill their intent
- To ensure that individual efforts lead to long-term change

Ministry of Health (MOH) Addresses Contraceptive Stock-outs

MOH report on reproductive health commodity security says the long procurement process is a critical cause of contraceptives stock-outs (**September 2012**)

Pledge Guarantee proposed as an advocacy option to cushion delays in procurement

June 2013

Further assessment finds Framework Contract more relevant than the Pledge Guarantee

September 2013

Dialogue initiated with the Contraceptive Security Committee

October 24, 2013

Meeting with MOH expert proposes inclusion of Implanon in the Framework Contract

Oct. 2013–July 2014

OUTPUTS

Agreement by the Contraceptive Security Committee to work on a Framework Contract

October 24, 2013

OUTPUTS

Agreement on proposal to include three FP commodities in the Framework Contract

June 28, 2014

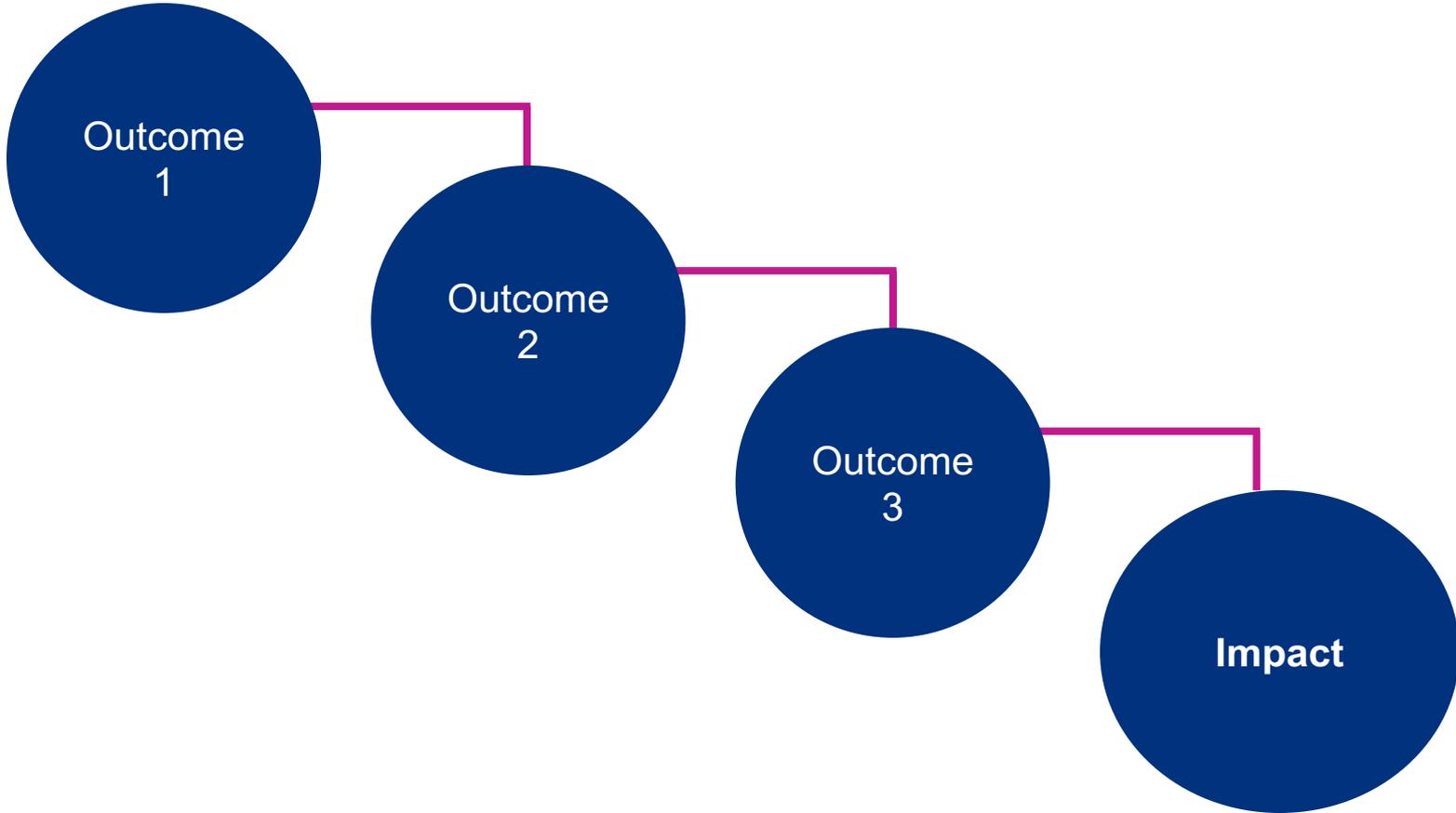

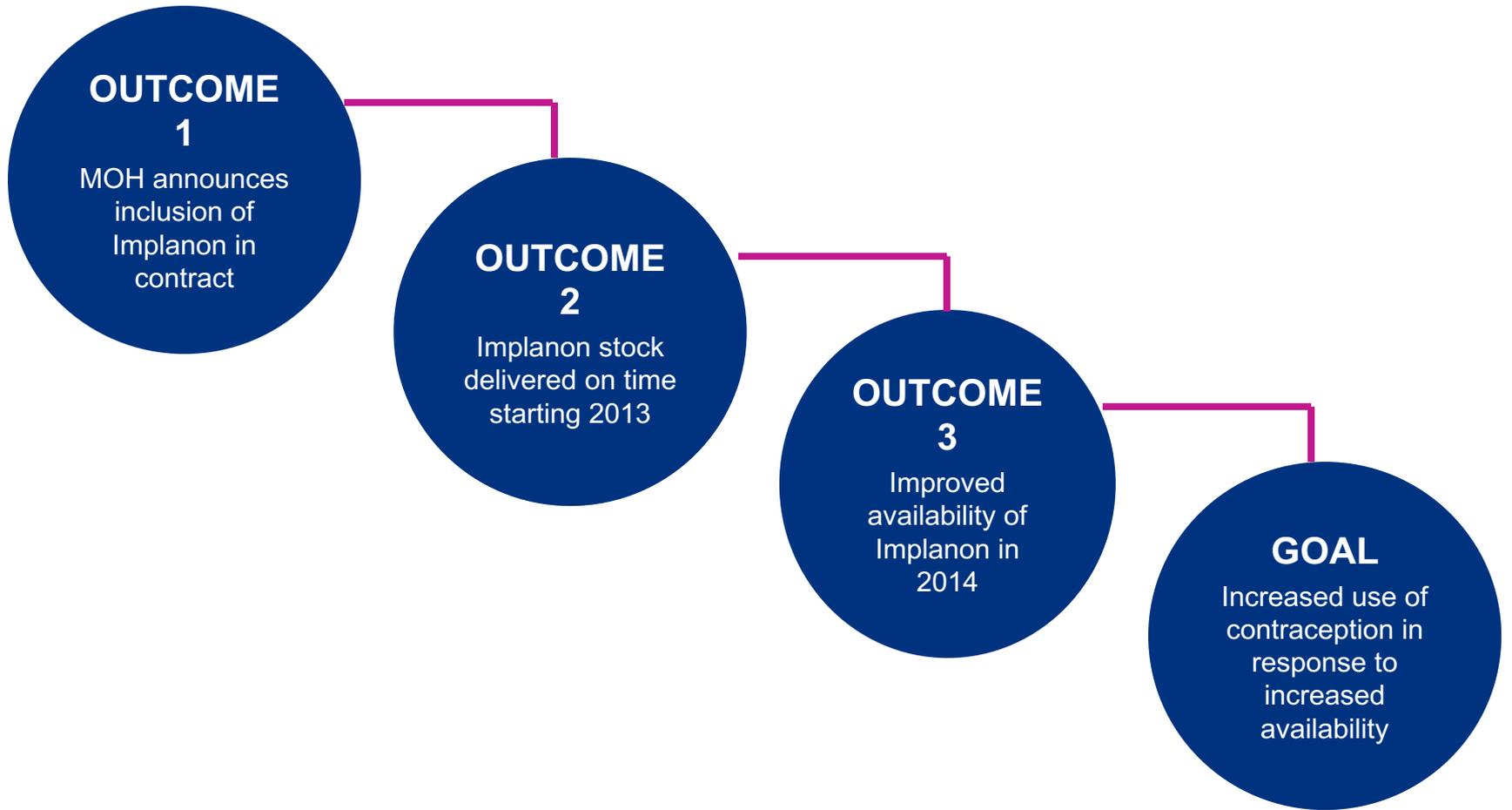

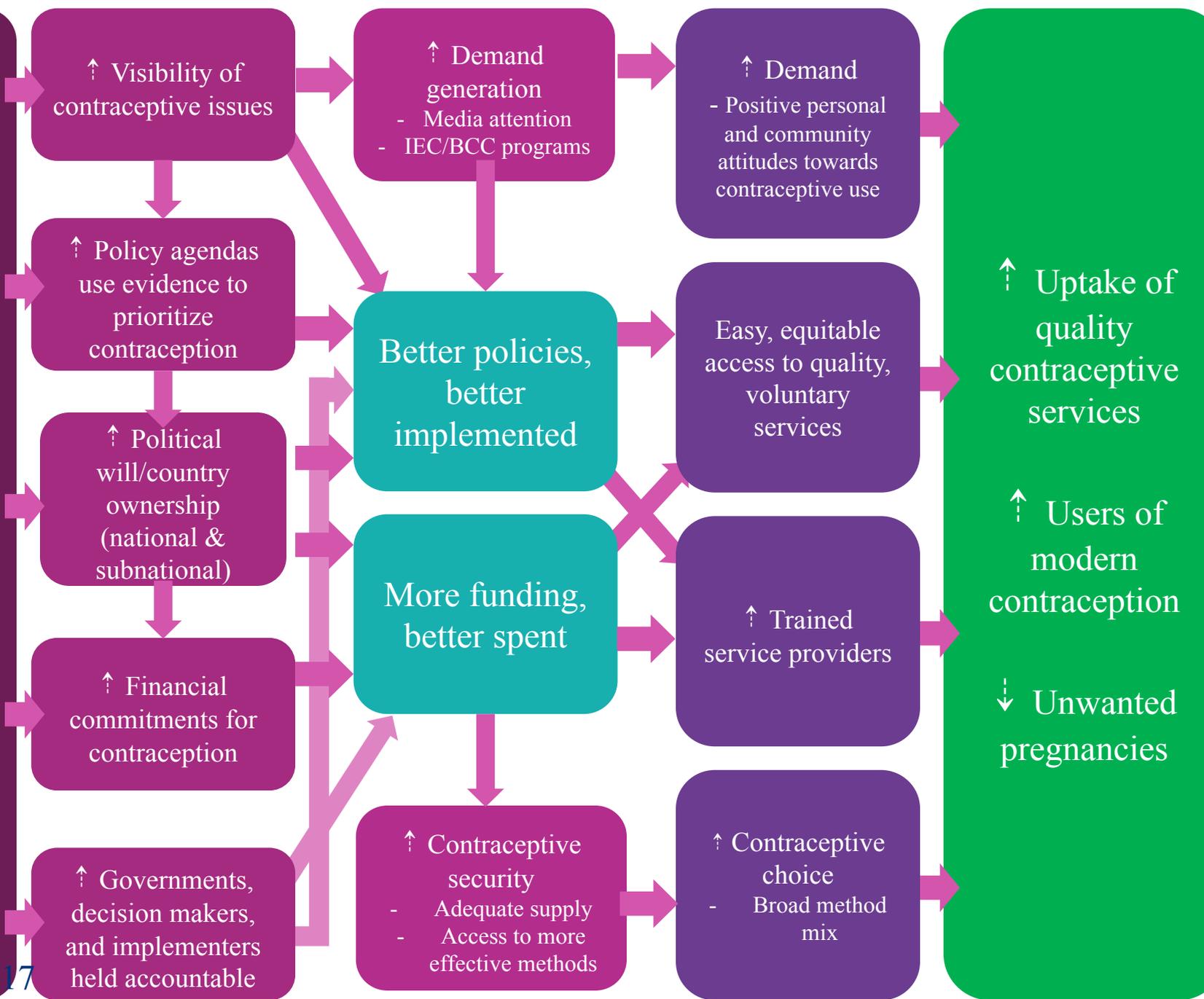

AFP's Theory of Change

1. Regulation change or budget allocated

2. Policies change & resources increase & improve FP

3. Change in provision of FP services

At each step

- Identify barriers and opportunities with AFP SMARTs
- Document and communicate quick wins
- Evaluate the decisions needed to continue progress toward impact
- Examine data to inform next steps in advocacy
- Evaluate the feasibility of taking the next step

Step 1— FP Policy Change/Allocation of Resources

- Kenya Quick Win

Siaya, Kakamega, Tharaka Nithi and Kitui counties allocate a combined total of \$246,279 to FP Fiscal Year 2015/2016

- Documentation

County budgets and annual reports

- What additional documentation could be provided?

Step 2—Policy Change & Resources increase and improve FP

DRC Quick Win

After DRC's commitment to FP2020, the government purchases S\$300,000 worth of contraceptives

Documentation

Programme National de Santé de la Reproduction (PNSR)

Step 3— Change in Provision of FP Services

- Zanzibar Quick Win

After refresher trainings for forecasting FP commodities for key staff in 10 districts, reduced stock outs and increased availability and access to FP commodities

- Documentation

Reports from the Tanzania health system

- What additional documentation could be provided?
- Is it feasible to move to Step 4? If not, why not?

Step 4— Change in Quality & Use of FP Services

- Indonesia

In Karanganyar district, after funds are disbursed, provision of long-acting contraceptive methods improves and use increases (32,4%-34,2%)

- Documentation

Reports from village FP teams. District service statistics from the government (BKKBN)

- What other data do you need to move forward?
- Are they ready to scale-up? Why or Why not?

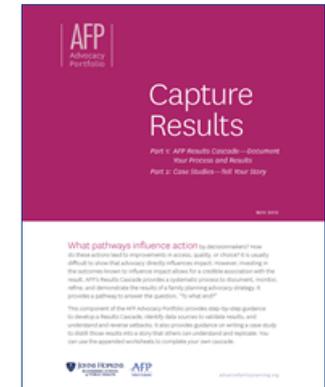
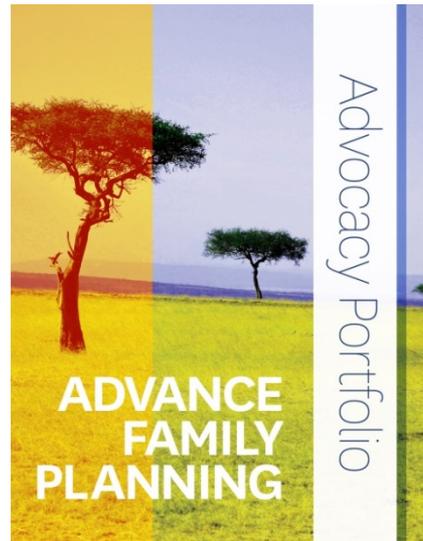

AFP aims to increase the financial investment and political commitment needed to ensure access to high-quality family planning through evidence-based advocacy.

Definitions and Key Concepts

■ Broad Goal/Impact

- Long-term outcome that describes the overall mission or purpose

Example: 120 million more women use contraception

■ Objective

- Brief, SMART statement of intent describing the result being pursued

- SMART: specific, measurable, attainable, relevant, time-bound

Example: Government budget for contraceptives increases by 10% by June

Definitions and Key Concepts

■ Quick Win/Outcome

- Discrete, critical policy or funding decision that must occur in the near term to achieve a broad goal

Example: Government allocates 10% more for contraceptives in June

■ Process Activities and Outputs

- Key activities required to achieve the Quick Win; activities result in outputs

Example: Family planning stakeholders meet with members of Parliament to solicit their support for an FP funding allocation

What is the Results Cascade?

- **Clearly and simply presents**

- Advocacy activities/outputs
- Outcomes/quick wins
- Intended impact
- Pathways that influence action and impact

- **Is a way to**

- Assess results and opportunities to refine strategy
- Document the actors and activities that generate change
- Track policy implementation and contributions to impact

Using the Decision Tree

- **Look ahead**—see how one Quick Win will influence another or change the strategy
- **Put advocacy in context**—which data can you monitor to track that advocacy is having an impact?
- **Focus on follow-through**—monitor how well policies are known and being implemented
- **Look beyond your own efforts**—which activities do others need to take up?
