Major advocacy wins

- Regional Medical Officers (RMOs) in 4 regions of Tanzania mainland have developed action plans for expanding AYFSRH services to at least 10% additional facilities in their regions.
- Ministry of Health in Zanzibar has developed an action plan and included it in the 2019/20 budget for service providers training and expanding AYFSRH services.
- Ministry of Health in Zanzibar has launched a new health facility with AYFSRH services in a university premise in Unguja Island

Advocacy Wins to Impact

- 30 youth-led CSOs in 6 regions of Mbeya, Mtwara, Lindi, Dodoma, Tanga, and Morogoro (5 CSOs in each) have advocacy capacity through AFP SMART with advocacy strategies on accountability on AYFSRH services provision
- In Tanzania Mainland TAYARH members are continuously engaging in Council Health Management Teams (CHMTs) on AYFSRH services plans and budgets during Comprehensive Council Health Plans (CCHP) meetings
- TAYARH members are part of a task team to prepare a training manual on post abortion care (PAC) for service providers in Zanzibar

Diffusion / Collaboration

- 14 Youth-led CSOs in 6 regions of Tanzania Mainland have mainstreamed AFP SMART approach in their advocacy programs to strengthen and sustain FP and RH advocacy
- 11 Youth CSOs in Zanzibar have mainstreamed AFP SMART approach in their advocacy programs to strengthen and sustain FP and RH advocacy
- TAYARH is working very closely with Ministries of Health in both the Mainland and Zanzibar on AYFSRH expansion

Sustainability

- TAYARH is working closely with Ministries of Health in both the Mainland and Zanzibar
- TAYARH is part of national and Council TWGs on RMNCAH, Adolescent health and Youth
- In Zanzibar, TAYARH is a member of the Social Welfare Committee of the House of Representatives (HoRSWC)
- TAYARH is a member of Tanzania Association of Non Governmental Organizations (TANGO) and the Association on Non Governmental Organizations in Zanzibar (ANGOZA)
